RENEWING YOUR FM-3 AND CAR PERMIT???

After renewing your FM-3, if you need to renew your car permit, below is a list of the documents required for this year.....

- **4 copies** of the letter stating that you have received permission from Immigration to stay in this country for 365 days; therefore you are requesting permission to extend your car permit for 365 days. *
- **2 copies** of the letter you received from DELEGACION REGIONAL EN EL ESTADO DE SINALOA REGULACION DE ESTANCIA when you renewed your FM-3. C.P. José Alfredo López Arregui Administrador de la Aduana de Mazatlán.
- **2 copies** of the original permit to import your vehicle. (Administración General De Aduanas Permiso De Importación Temporal De Vehículos)

*(letter requesting permission to extend vehicle permit)

Por medio de las presente, me permito informar a usted que el Instituto Nacional de Migración de este país, me ha concedido prorroga en mi calidad migratoria por el tiempo de 365 días para permanecer en México que concluye el día (insert expiratation date of your renewed FM 3 here i.e., 10 de Octubre 2007), lo que estoy avisando a esa autoridad aduana para efectos del articulo 106, fracción IV, inciso a de la Ley Aduanera, en la importación temporal de mi vehículo marca (make of car i.e. Chrysler), modelo (model year i.e. 2004) y número de serie (serial number on vehicle), efectuada por la Aduana Fronteriza (city and state in México where you received permission to bring your vehicle into México). Members present: Dee Hulen, Susan Silva, Jacque Demmer, Bruce George; committee chairmen Fr. Jim Story; proxy holders Jerry Lippman [for Murry Page], Fr. Jim Story [for Robert Ryckman]; Lee Story acting secretary & Gayle Villalobos-Volunteer coordinator proffer.

Meeting was called to order by Dee Hulen, Vice President at 9:15 AM. A quorum was established. Susan made a motion to approve the August Board meeting minutes; 2nd-Jacque; unanimously approved. Dee made a motion to approve the September Board meeting minutes; discussion followed with suggested changes; Jacque made a motion to accept the amended September Board minutes; 2nd-Susan; unanimously accepted.

Old Business:

Membership report-Fr. Jim Story [for Robert Ryckman]: 489 total members. Robert will return by the November meeting. Murry Page sends a personal e-mail to new members, welcoming them.

General meeting location for December, January & February- Susan: La Vinea seats 300 people, she will talk to the principals as soon as they return to town to discuss booking the location.

Clarification of the duties of a proxy-Dee: Reviewed & explained the procedures for the Board.

Member services-Fr. Jim Story: Committee is out of town.

Newsletter-Susan: Will talk to Rebecca to see how it is progressing.

Events-Susan: 2 cancellations for the bus trip to Morelia; she is confident that the spaces can be filled. 22 February is the tentative date for the Copper Canyon trip. A bus trip is planned to Tonala at the end of January. Events-Bruce: Will discuss the Stars of Tomorrow with the MCA School.

Volunteer Coordinator-Gayle: 44 volunteers living in town year round. She requested that all committee chairmen —email her a detailed list of the help that is required for each committee.

New Business:

CPR classes-Dee: Asked the Board to consider offering classes. Will ask the Continuing Education Committee to research this.

Flu Shots-Susan: Will organize administering them to interested members in November. Possibly include pneumonia shots also.

New proxy form-Dee: Lee has suggested a self explanatory form for the Board members; which will be taken under review.

Adjournment-Jacque made a motion to adjourn; 2nd-Susan; approved. Adjourned at 10:45 AM.

FOUNDATION REPORT September 28, 2006

Due to the fact that the committee members who are present in Mazatlan at this time have been working diligently to assemble and distribute school supplies, we have cancelled the September meeting of the committee.

School supplies, backpacks, polo shirts and vales for shoes and socks have been distributed to all students at Sor Juana School including a follow up order and second distribution of additional polo shirts, supplies, etc. for students that were not registered at the time the teachers provided student names and numbers per classroom. All six teachers received packets of supplies as well.

All the students at Vicente Guerrero and Josefina Osuna Perez afternoon session have received individual packets of school supplies and their teachers 6 at Vicente Guerrero and 12 at Josefina Osuna Pérezhave also received packets of supplies.

Distribution of school supplies to all students and 12 teachers at Josefina Osuna Perez morning session will take place on Friday September 29th.

Sister Aurora, who is now in charge of the boys at Hogar San Pablo, has not yet submitted her list for school supplies, but she has taken the boys down to purchase their school uniforms, shoes and socks. There are currently 25 boys at Hogar that attend school.

The foundation has given En Busca de una Sonrisa \$6,600.00 pesos from the Ted and Katie Carney donation to pay for 2 weeks of labor by brick layers. En Busca will

receive an additional \$3,600.00 pesos for labor expenses for the week of September 25th-29th.

The foundation to date has spent \$375.99 for supplies for En Busca.

There are two students at Jose Felipe Vale School (El Venadillo) who require the use of hearing aids. Jim Story has provided the necessary batteries for their hearing aids. The foundation is researching the feasibility of providing some type of breakfast for the kids in "our" schools. The directors have expressed that one of the major problems at their schools is that the kids come to classes hungry.

The Foundation would like to sincerely thank those who generously donated \$19,225.20 pesos to the Foundation. See the newsletter for the names of our donors.

The foundation committee would like to make a motion that FOM order more FOM T-shirts.

Painting Vicente Guerrero: The school would like to have the paint delivered to them on Oct 19 for painting to be done on Sat the 21st October. The school needs to be checked to make sure the walls inside and out have been prepared for painting...i.e. scraped where needed, nails removed from interior and exterior walls. Also, I recommend that the FOM logo be painted on the side of the school.
